



Have Your Say – Proposed improvements at the intersection of Hoxton Park Road, Banks Road and Joadja Road, Hoxton Park

The NSW Government is funding this proposal as part of its \$300 million Urban Roads Pinch Point Program, which aims to reduce congestion and improve travel times on Sydney's busiest corridors.

Roads and Maritime Services is seeking feedback by **Monday, 12 February, 2018** on proposed improvements at the intersection of Hoxton Park Road, Banks Road and Joadja Road in Hoxton Park.

The proposal includes:

- Providing dual eastbound right turn lanes on Hoxton Park Road into Joadja Road
- Providing dual southbound right turn lanes on Banks Road into Hoxton Park Road
- Widening the eastern side of Banks Road to suit new configuration
- Traffic lights added to the left turn slip lane on Hoxton Park Road into Joadja Road.

Key benefits

The proposal will:

- Improve the capacity of the intersection and reduce congestion
- Improve travel times, particularly in peak hours
- Improve traffic flow at this intersection and approaches
- Improve safety for pedestrians and road users.


