



Community feedback on recommended preferred option will be invited.


This feedback will be considered before a final decision is made on the preferred option.




Announce short-list of route options

Value Management

Value Management is a structured, facilitated, process in which decision-makers, stakeholders, technical specialists and others work collaboratively to bring about value-based outcomes in systems, processes, products and services

Some Attributes of Value Management

- ➤ Multi-disciplinary
- >Professionally facilitated
- >Structured workshop
- ➤ Shared understanding
- ➤ Shared goals and objectives
- > Working together to create solutions
- ➤ Ownership and commitment



Typical VM structure – Australian Public Sector (2-day workshop, large groups - typically 20-30 people)

- Preparatory work
- ➤ Workshop:
 - Preliminaries
 - Phase 1: Information / Understanding Phase
 - Phase 2: Analysis and Determining Criteria
 - Phase 3: Option Evaluation
 - Phase 4: Drawing Conclusions, Making Recommendations and Preparing an Action Plan
- > Action and Implementation



Attributes of the Workshop Participants

- > Express your opinion
- > Allow others to express their opinion
- > Recognise that all views are important
- > Stay engaged with the process and stay patient
- > Be open minded and listen to the other points of view
- Make recommendations "on balance" of **all** the views (including your own but not just your own) to achieve the project objectives
- ➤ Don't criticise people focus on the task
- > Be positive
