

# Establishing a site compound at Pearce's Corner, Wahroonga from Monday 12 April

March 2021

The NSW Government is widening the Pacific Highway to create three continuous northbound lanes between Turramurra and Wahoonga. We're also upgrading a number of intersections along this section of the Pacific Highway. These improvements will help ease congestion, reduce travel times and improve safety on the Pacific Highway.

This work began in October 2020. Until now, we have been using 100-102 Fox Valley Road, Wahoonga as the site compound for this work. As the project progresses, we need more space to carry out our activities.

Following further investigations, Pearce's Corner, at 1 Pacific Highway and 2-12 Pennant Hills Road, Wahoonga, has been identified as a more suitable site compound for our work on the Pacific Highway.

From **Monday 12 April**, we will start using Pearce's Corner as the site compound for our project on the Pacific Highway. **We will be using this site until the completion of the project** expected in **late 2022**.



## What is a site compound?

A site compound is a temporary location where we store materials and equipment and provide amenity sheds and parking for workers and site vehicles to support a construction project. It is an essential part of our work. A site compound needs to be close to the project worksite and big enough to store materials and equipment.

## What we're doing

To establish the site compound at Pearce's Corner, we need to:

- install fencing
- install measures to mitigate noise and control sediment and erosion
- set up the offices and amenity sheds
- install temporary sheds
- install temporary paved areas for parking and laydown of equipment and materials.

This work will be carried out between **Monday 12 April** and **Thursday 29 April**. Our work hours will be from **Monday to Friday** between **7am** and **6pm** and on **Saturday** from **8am** to **1pm**.

We will use the site compound and offices until the project is completed in **late 2022**.

Our normal working hours will be from **Monday to Friday** from **7am** to **6pm** and on **Saturday** from **8am** to **1pm**. We also work **up to five nights** a week between **Sunday** and **Friday** from **8pm** to **5am** the next day. We will not work on public holidays. There may be times that we work outside these hours, but we will notify you in advance.

## How this will affect you

During the establishment and the use of the site compound, there will be some impacts such as noise and dust. We will do everything we can to minimise impact to neighbours, particularly in relation to noise and light spill. For example, we will:

- implement noise mitigation measures onsite to reduce impact of noise
- direct any lights away from neighbours where possible
- ensure vehicles or equipment are turned off when not in use
- require workers to be considerate of neighbours when they use the site.

We will keep you informed of the progress of our work.
