

## Sutherland to Cronulla

### COMMUNITY NOTIFICATION

February 2023

Transport for NSW (TfNSW) is rolling out new technology to upgrade Sydney's rail network and introducing modern signalling as part of the Digital Systems Program.

The Program will replace current signalling and train control technology with modern, internationally proven, intelligent systems. It will help improve reliability and increase capacity on Sydney's railways once implemented widely across the network.

### Upcoming works

Various work will continue in February along the Sutherland to Cronulla rail corridor during standard hours – **Monday to Friday 7am to 6pm** and **Saturday 8am to 1pm**.

### Weekend work – Saturday 25 February to Sunday 26 February 2023

**Between 8am and 6pm on both Saturday 25 February and Sunday 26 February**, works are planned during a scheduled Sydney Trains weekend possession.

Staff will begin mobilisation on site from 6am Saturday, however noise generating works will not begin until at least 8am Saturday and Sunday.

Work activities will include installation of trackside signage and maintenance works as well as testing of signalling infrastructure.

The work in your area will not be continuous. Every effort will be made to keep noisy works to a minimum and to reduce impacts to the community wherever possible.

Please note that Sydney Trains is also undertaking track maintenance including track grinding and resurfacing work within the rail corridor during this time and have notified the community separately.

#### What equipment will be used?

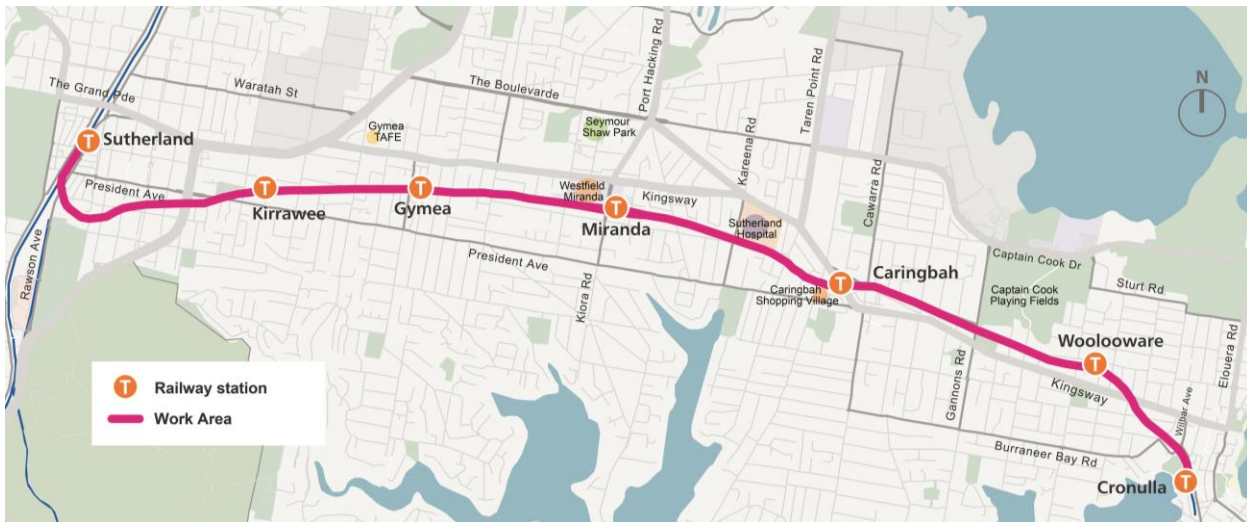
Equipment will include excavators with hammer attachments, hand tools and other construction vehicles.

### What you may notice

TfNSW is committed to minimising noise impacts on the community. The use of trucks to deliver machinery, equipment and materials may also occur outside of standard work hours to ensure the safety of the community and our workers.

We switch off equipment when it is not being used, place equipment as far away from properties as possible and monitor our work activities to make sure noise levels are being managed effectively.
